Recommended Action:

Approve Resolution delegating authority to the General Manager to execute agreements within the ordinary course of CC Power business consistent with CC Power approved policies and within the best interest of CC Power.

Discussion:

On February 15, 2023, the CC Power Board appointed Alexander Morris as CC Power's General Manager. Pursuant to Section 4.07 of the CC Power Joint Powers Agreement (JPA), the Board shall appoint a General Manager to serve at the pleasure of the Board, and which shall be responsible for the day-to-day operation and management of CC Power. The JPA provides that the General Manager may enter into and execute contracts in accordance with the policies established and direction provided by the Board.

On October 19, 2022, the CC Power Board delegated authority to the General Manager to execute contracts for consulting services as needed and as consistent with the CC Power Board approved budget. The authority delegated in this Resolution would expand on that authority and delegate authority to the General Manager execute agreements and contracts necessary to facilitate the day-to-day operations of CC Power.

CC Power Staff has previously brought standard day-to-day agreements to the CC Power Board for approval and delegation of authority to the General Manager to execute such agreements. As the CC Power Board has not previously directly established policies or direction to the General Manager delegating authority to execute these types of agreements, this Resolution explicitly ensures that the General Manager may enter into, and execute day-to-day agreements including, but not limited to, Non-Disclosure Agreements, Memorandums of Understanding, and other agreements within the ordinary course of CC Power business which are within the CC Power approved budget and within the best interests of CC Power and its members.

Appoint the General Manager as the CC Power Personnel Manager which would grant authority to oversee and manager all personnel and employee matters including, but not limited to, the oversight of employee reviews and bonuses, and employee benefit programs.

Discussion:

Pursuant to Section 4.07 of the CC Power Joint Powers Agreement (JPA), the Board shall appoint a General Manager to serve at the pleasure of the Board, and which shall be responsible for the day-to-day operation and management of CC Power.

In the management and oversight of CC Power's day-to-day operations, the General Manager is well positioned to manage the current and future employees of CC Power. This may include, among others, the management of employee reviews, salary changes, bonus structures, and employee benefit programs.

This Resolution ensures that the CC Power General Manager has delegated authority to manage any and all personnel and employee matters that may arise within the ordinary course of CC Power business. All action taken under this delegation of authority will be in accordance with CC Power approved policies and budgets as well as in accordance with all applicable laws.

 Appoints the CC Power General Manager as Personnel Manager of CC Power and delegates authority to the General Manager to manage all personnel and employee matters on behalf of CC Power in accordance with CC Power approved policies and budgets and in accordance with all applicable laws.

Subject: Shared Service – Resource Adequacy Report

Recommended Action:

Approve CC Power to negotiate and execute a purchase agreement for a Resource Adequacy report, in accordance with any not-to-exceed amounts, if agreed to by members.

Discussion:

CC Power members may at times benefit from joint-action, shared services, and bulkpurchases. CC Power member-CCAs may at times purchase reports and information services and or trainings as part of their ongoing power procurement functions and related operations.

On November 8, 2023, participants in CC Power's Resource Planning Working Group (RPWG) agreed to recommend exploration by CC Power for a potential bulk purchase of a report on Resource Adequacy, as part of a discussion about a shared-services project to pursue information services and or possible training services. As this expense was not contemplated in the 2023-2024 approved budget and work-plan, Board consideration and approval of this incremental spending is appropriate.

CC Power therefore seeks Board Approval to pursue and potentially execute a bulk-purchase of a Resource Adequacy report following RPWG recommendations. This Resolution, if approved, authorizes the CC Power General Manager or his or her designee to negotiate a bulk purchase of a RA report and to allocate costs equitably among participating members. These costs would not impact General & Administrative (G&A) costs and would be categorized as project expenses shared among project participants. Participation is optional for each member, and non-participating members will have no incremental costs due to this effort. As appropriate, the motion may include a not-to-exceed amount.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of CC Power hereby approves the pursuit and acquisition of a Shared Services Resource Adequacy Report and amends the 2023-2024 Budget to allow the purchase of a Resource Adequacy Report in an amount no greater than \$50,000.
